GENERAL TERMS AND CONDITIONS

A. ACCEPTANCE OF REGISTRATION

Requests for participation must be made on the official form. With his valid signature, the sponsor agrees, in particular:

• To adhere to the present regulations and to the decisions of the organizer based thereon. It is not possible to act against the organizer's decisions.

• The organizer has the right to accept or decline registrations. The registration serves as a contract once it has been confirmed in written form by the organizers. Registrations may be rejected without justification. The exhibition management provides no guarantee as to claims made by sponsors or third parties, relating to the acceptance or lack thereof by companies and/or products.

B. WITHDRAWAL OF REGISTRATION

If a sponsor withdraws from the contract after having signed it, the sponsor will be liable for the following compensation to the organizer:

- for withdrawal more than 12 weeks before the beginning of the event: 30% of the booked services
- for withdrawal between 6 and 12 weeks before the beginning of the event: 60% of the booked services
- for withdrawal up to 6 weeks prior to the event: 100% of the booked services

C. CONTRACT PARTY
