That is why the working group of cardiovascular biology was founded by **clinicians and researchers** working in cardiology and in the vascular domain 20 years ago. This interaction is the specificity of our group, which is also supported by the Swiss Society of Cardiology (<http://www.swisscardio.ch>).

- To provide an open forum for **cardio-vascular** scientists (basic researchers and clinicians)
- To promote and enhance education for young colleagues
- To intensify collaborations among researcher within Switzerland and with industry
- To provide an annual meeting platform for network programs

The meeting will take place in the main building, Lecture hall A 003, of the [UniS](#) of the University of Bern located at **Schanzeneckstrasse 1, 3012 Bern**. An apéro in a **restaurant in Bern** will be the social highlight of this event after the scientific conference.

If included in the package, free registration for company representatives includes catering and venue fees. We, however, kindly ask the representatives to individually pay for and organize their hotel overnight stay. The cost of parking is not covered. The social event/Dinner after the conference should be booked separately, and an additional fee (70 CHF) is required.

*Those are cash prizes given directly to the winner of each category after subtraction of administration fee (50 CHF). The prize will be called by the company's name. The logo of the sponsor of oral and poster prizes will be shown in social media together with the announcement of the winners after the conference. GENERAL TERMS AND CONDITIONS

A. ACCEPTANCE OF REGISTRATION

Requests for participation must be made on the official form. With his valid signature, the sponsor agrees, in particular:

- To adhere to the present regulations and to the decisions of the organizer based thereon. It is not possible to act against the organizer's decisions.
- The organizer has the right to accept or decline registrations. The registration serves as a contract once it has been confirmed in written form by the organizers. Registrations may be rejected without justification. The exhibition management provides no guarantee as to claims made by sponsors or third parties, relating to the acceptance or lack thereof by companies and/or products.

B. WITHDRAWAL OF REGISTRATION

If a sponsor withdraws from the contract after having signed it, the sponsor will be liable for the following compensation to the organizer:

- for withdrawal more than 12 weeks before the beginning of the event: 30% of the booked services
- for withdrawal between 6 and 12 weeks before the beginning of the event: 60% of the booked services
- for withdrawal up to 6 weeks prior to the event: 100% of the booked services

Additional compensation may be claimed, e.g. for orders which have already been completed (printed advertising, etc.).

C. CONTRACT PARTY

The registered sponsor/exhibitor is the contract party of Life Sciences Switzerland (LS2).

D. PAYMENT CONDITIONS

The payment period is 30 days. The invoice total is to be paid without deductions. Delayed payments will be subject to 5% interest. For sponsors/exhibitors to be granted access, all payments must have occurred in advance. Any additional services are added to the final account after the event. **Quoted prices do not include statutory VAT.**

E. INSURANCE/LIABILITY INDEMNITY

Liability insurance is obligatory for all exhibitors and must be covered by the exhibitors individually. The organizer is not liable for covering any insurance for the exhibitor/sponsor.

F. DATA PRIVACY INFORMATION

Due to data privacy reasons, we won't give out participant information to our sponsors and exhibitors. We thank you for your understanding. With your registration, you agree that we may use photos and video material taken during the meeting for advertising and marketing purposes.

G. COMPLAINTS

Complaints concerning incidents during the event must be addressed to the organizers immediately.

H. EXECUTION CLAIMER

In the event of unexpected political, economic, social, health events or any other unforeseen incidents that hinder or complicate the event's execution, the exhibitors are not entitled to claim damages. The organizer is hiring a professional platform to host the online meeting and cannot be held responsible for technical issues.

I. PLACE OF JURISDICTION

Place of jurisdiction for any disputes arising in connection with the event is Bern. Any verbal agreements and special arrangements require written confirmation. The exhibitor regulations are an integral part of any contract. All subsequent circulars and written announcements are to be considered parts of these regulations.
